### Miss Rodeo Arkansas 2024 Performance Contract

(Hereinafter called "Agreement")

This agreement is between	, Miss Rodeo Arkansas 2024, and the Miss
Rodeo Arkansas Scholarship Organization.	

#### Miss Rodeo Arkansas 2024 agrees:

- She will have reached 21 years of age by November 1, 2024 and I will be no older than 26 years of age by December 31, 2024. I will provide a copy of a government issued identification and/or birth certificate verifying my age.
- She agrees that by signing this contract, she is also agreeing to abide by the rules set forth in the Miss annual schedule, Perpetual Item Contract, as well as Miss Rodeo Arkansas Scholarship Organization Rulebook and Miss Rodeo America Rulebook. NO EXCEPTIONS.
- She understands and agrees that this contract is subject to change at the discretion of the Executive Board.
  - The Miss Rodeo Arkansas Scholarship Organization has the right to alter, amend, add or remove any rule or guideline, at any time, for any reason they deem necessary to uphold the integrity of the organization.
- She understands that any deviation of rules and expectations listed c result in consequences to be determined by the Executive Board.
- Miss Rodeo Arkansas will not represent any brand, company or entity other than that of the Miss Rodeo Arkansas Scholarship Organization. **NO EXCEPTIONS.**
- I have not authorized any person, business, brand, firm or corporation to use my name, photograph, voice or image nor present or future title in connection with an endorsement or advertisement of any commercial product or service: and I am not under any contract or other obligation to any person, firm or corporation with respect to my present title, and further, I have not made any commitment or have any legal obligation which would prevent my participation in any appearance as Miss Rodeo Arkansas.
  - I am not under any contract that may conflict with Miss Rodeo Arkansas or its sponsors or Miss Rodeo America and their sponsors.
  - I will not represent any other brand or likeness other than that of Miss Rodeo Arkansas.

•	I am a naturally b	orn female citizen	of the United States of America and reside in the Cit
	of	County of	State of Arkansas.

- As a young woman of legal age, I realize that this contract is between myself & the MRARSO Board.
- She has never been married, had a marriage annulled or been pregnant, nor shall she during the lady-in-waiting period, or the year of her official reign (January 1 December 31) nor shall she be the guardian of any child or become a guardian of any child while this contract is valid.
  - In addition, she shall not maintain any form of cohabitation with another male person, other than family, during the same time period.
- She is a graduate of high school or equivalent and has never been convicted of any crime.
  - o In the event she has been convicted of a crime, the Executive Board will use their discretion to

deem the conviction appropriate or inappropriate.

- She is a current physical Arkansas resident, enrolled in and physically attending a college/university in the State of Arkansas or working within Arkansas, during the year of her reign.
- I am of good moral character and have never been convicted of any crime, other than minor traffic violations.
- Miss Rodeo Arkansas symbolizes the youth of Arkansas and that she is the ideal, western type American girl, and is the person who will represent professional rodeo, the equine industry and the Miss Rodeo Arkansas Scholarship Organization as she travels throughout Arkansas and surrounding states.
  - Any behavior and/or activities performed by Miss Rodeo Arkansas that would contradict this ideal
    image may result in the termination of her reign along with the forfeiture of any and all prizes,
    scholarship monies and sponsorship monies, or the placement of the titleholder on travel/
    appearance probation.
    - This includes but is not limited to using illicit drugs, use of tobacco products, cursing, drinking alcohol, the commitment of crimes of moral turpitude, traveling to or from any official Miss Rodeo Arkansas appearance with a male companion (other than family), publicly arguing, having a poor attitude or making undue demands during any official appearance as Miss Rodeo Arkansas, the placing of any inappropriate photos and/or text on the internet.
- Miss Rodeo Arkansas Scholarship Organization may also take into consideration the actions of Miss Rodeo Arkansas when she is not on official appearances.
- She agrees to utilize the social media accounts Miss Rodeo Arkansas Scholarship Organization have set up. These accounts include, but are not limited to Facebook, Instagram, Twitter, etc. She will remove any photos, videos or text she is asked to remove by the Miss Rodeo Arkansas Scholarship Organization on not only these platforms, but also her personal accounts.
  - O She agrees that the Miss Rodeo Arkansas social media accounts are to consist of:
    - 50% travels, rodeo & Miss Rodeo Arkansas sponsors
    - 25% Miss Rodeo America sponsors
    - 25% Miss Rodeo Arkansas platform & personal posts
  - Miss Rodeo Arkansas will not have a personal TikTok account.
- I have achieved an advanced level of horsemanship skill.
- I have never been accused or convicted of any kind of animal abuse or neglect.
- I understand that at no time during my reign shall I do undue harm or unnecessarily discipline any animal within my care, mine or others', during a rodeo or related official function.
- To purchase and carry insurance coverage for any vehicle she is granted the use of during her reign as Miss Rodeo Arkansas, including full property damage, collision and liability coverage and shall name Miss Rodeo Arkansas Scholarship Organization as additional insured and shall provide copies of such insurance contract to the board. In addition, she agrees to notify the board within twenty-four hours of any accident involving said vehicle and/or trailer.
- To carry her own health insurance during her reign as Miss Rodeo Arkansas and if she is injured at any

function where she is acting as Miss Rodeo Arkansas she shall notify the board within twenty-four hours of the incident.

- I agree to save and hold harmless the Miss Rodeo Arkansas Scholarship Organization, its directors, officers, sponsors, volunteers and agents for and from all liability for my actions and conduct during the term as Miss Rodeo Arkansas.
- To be recognized and to make appearances as Miss Rodeo Arkansas from the date of January 1 December 31.
  - Any appearances made during this period MUST be as Miss Rodeo Arkansas and she agrees that she will not represent any other title by wearing any other crown, chaps or banner during this period of time.
    - She shall not become a contestant or participate in any other beauty or talent pageant/contest during this time period.
- To fully communicate with the National Director concerning any and all requested appearances made of her as Miss Rodeo Arkansas.
  - No appearance will be agreed upon by Miss Rodeo Arkansas without prior approval from the National Director, with priority given to any and all PRCA rodeos held within the state of Arkansas.
  - Any out-of-state travels must be approved by the National Director. The titleholder understands that she must be invited to attend out-of-state events by other committees.
  - There will be no contact made by Miss Rodeo Arkansas to potential appearances. She will
    notify the National Director of her interest to attend and the National Director will make
    contact.
- Titleholders are not permitted to contact Miss Rodeo Arkansas Pageant sponsors directly. Always check with the Executive Board prior to doing so.
- Following her reign, she will attend the coronation ceremony of the new Miss Rodeo Arkansas.
- To be dressed in full western attire when making official appearances on behalf of Miss Rodeo Arkansas Scholarship Organization as Miss Rodeo Arkansas.
  - This includes the official Miss Rodeo Arkansas crown, belt buckle and banner as provided by Miss Rodeo Arkansas Scholarship Organization, as well as long sleeved blouse with Wrangler pant product or a long-sleeved western style dress or skirt with blouse, western hat, belt and western boots.
  - Miss Rodeo Arkansas will take care to be perfectly groomed at all times including the time she travels to and from such appearances and functions.
- At every appearance, Miss Rodeo Arkansas will never be on her phone for any reason other than an immediate emergency.
- Following appearances, Miss Rodeo Arkansas MUST give thank you cards to each and every person on the
  rodeo committee, host home, and/or anyone who directly helped make your appearance be a success. No
  exceptions.
- Once weekly, you will create and publish a post dedicated to a sponsor of the Miss Rodeo Arkansas Scholarship Organization.
- To have official Miss Rodeo Arkansas portraits taken by our professional photographer, Sherry Smith, in a

timely manner and the board will have final approval of said portraits as well as any future photographs to be used for any publicity purposes and for Miss Rodeo America. **NO EXCEPTIONS.** 

- To secure autograph sheets to be used during her reign as Miss Rodeo Arkansas. The layout of these sheets
  must include sponsors names and logos. (Refer to the sponsor levels for specific direction). NO
  EXCEPTIONS.
- To purchase chaps to be worn in the Miss Rodeo America Pageant by Sara Pro Lazy P Creations.
- If any additional chaps are purchased through her reign, Miss Rodeo Arkansas will purchase these chaps through Sara Pro Lazy P Creations.
  - In return, you will receive an autograph bag/purse made by Sara Pro, for free, with the purchase of those chaps.
- To hold a "Coronation Celebration" in January. She agrees that this event is to be held in or near her hometown and that she will work under the direction of the National Director and Executive Board and will follow the guidelines for said event that are provided by Miss Rodeo Arkansas Scholarship Organization.
- To fully disclose to Miss Rodeo Arkansas Scholarship Organization any financial or product donations made to her in support or sponsorship of her duties as Miss Rodeo Arkansas.
- The National Director and Executive Board must approve the titleholders Miss Rodeo America wardrobe by August 31. The Miss Rodeo Arkansas Scholarship Organization does not require all new clothes to be made, but must approve all clothing choices. It is **required** to plan ahead for the MRA wardrobe.
  - You must follow the annual schedule.
- To plan and hold a "Las Vegas Send-off Fashion Show" during the month of October or November, prior to
  her departure for the Miss Rodeo America Pageant for the purpose of receiving feedback on the attire she
  will wear during the Miss Rodeo America Pageant. This date needs to be secured well in advance. The
  matrix provided by Miss Rodeo America, Inc. MUST be followed.
- To use the official Miss Rodeo Arkansas logo as provided by the Miss Rodeo Arkansas Scholarship Organization in an appropriate manner as allowed by the Executive Board.
  - The logo is a registered trademark of Miss Rodeo America, Inc. & must be utilized in appropriate manners.
- To be solely responsible for her personal property and well-being; and she shall neither ask for, expect, nor receive compensation or reimbursement from Miss Rodeo Arkansas Scholarship Organization for any loss sustained by her as a result of participating as Miss Rodeo Arkansas. She shall save and hold harmless the Miss Rodeo Arkansas Scholarship Organization, Executive Board and/or committee from any and all liability for her actions and conduct during her term as Miss Rodeo Arkansas and for either committee's action or conduct with respect to any rights herein granted.
- To honestly prepare for and represent Miss Rodeo Arkansas Scholarship Organization in the Miss Rodeo America Pageant. If she fails to attend the Miss Rodeo America Pageant and such failure is caused by her own volition, Miss Rodeo Arkansas shall reimburse Miss Rodeo Arkansas Scholarship Organization all amounts expended on her behalf if such demand is made by Miss Rodeo Arkansas Scholarship Organization.
  - This shall include, but not be limited to, the required fees for participation at the Miss Rodeo America Pageant as well as all sponsorship monies raised and reimbursed to her as well as all

- product donations made to her on behalf of her role as Miss Rodeo Arkansas.
- If she fails to attend the Miss Rodeo America Pageant due to her own volition, any and all
  promised scholarship monies from Miss Rodeo Arkansas Scholarship Organization will be
  forfeited. In addition, all prizes will be returned to the Miss Rodeo Arkansas Scholarship
  Organization.
- To receive health coaching and actively participate in a workout plan.
- To take horseback riding lessons, speech lessons, modeling lessons, interview lessons and/or visits with makeup and other appearance consultants with whatever individual(s) Miss Rodeo Arkansas Scholarship Organization selects or approves of, if Miss Rodeo Arkansas Scholarship Organization requests her to do so in preparation for the Miss Rodeo America Pageant.
  - o To attend weekly coaching sessions as directed by the National Director & Executive Board.
- To return perpetual prizes to Miss Rodeo Arkansas Scholarship Organization when requested.
- I understand that all prizes, gifts and monies may be dependent upon the sponsor to deliver them.
- It is my understanding that I cannot be escorted to, from or during any official function as Miss Rodeo Arkansas by anyone other than a chaperone approved by the Miss Rodeo Arkansas Scholarship Organization. Male, non-family members are NOT permitted for chaperone/escort duties.
- I agree that my Miss Rodeo Arkansas buckle, crown and banner will not be possessed by anyone but myself, worn by anyone but myself or loaned out to anyone during or after my term as Miss Rodeo Arkansas without permission from the Miss Rodeo Arkansas Scholarship Organization.
- I also agree that unless illness and/or severe inclement weather should occur during my reign, that I will attend all functions and be present all days and nights during the 2025 Miss Rodeo Arkansas Scholarship Pageant.
- I agree that I will represent myself as Miss Rodeo Arkansas during the year of my reign. Thereafter, I may represent myself as "Former Miss Rodeo Arkansas" or "Former MRAR".
- If Miss Rodeo Arkansas fails or refuses to perform the terms and conditions of the Agreement, Miss Rodeo
  Arkansas Scholarship Organization may in its discretion require her immediate resignation, with or without
  cause, and she shall immediately forfeit and return to Miss Rodeo Arkansas Scholarship Organization all
  awards, prizes, sponsorship monies and education funds which she received or to which she would
  otherwise be entitled.
  - O In the event of her resignation or removal, Miss Rodeo Arkansas Scholarship Organization may select her successor who will be entitled to receive such prizes, awards and education funds as may be determined by Miss Rodeo Arkansas Scholarship Organization. If prizes are not forfeited in the event the titleholder relinquishes her title Miss Rodeo Arkansas Scholarship Organization may seek legal action against said titleholder.
- I understand that during the lady in waiting period, I will only refer to myself as "Miss Rodeo Arkansas Lady in Waiting."
  - During that period, I will not utilize, share or post any official headshot of myself with the Miss Rodeo Arkansas crown.
    - This is included, but not limited to, social media, potential appearances, etc.
  - The National Director will be the only party scheduling appearances during the lady in waiting period and during my reign. **No exceptions.**

- I understand that information about my coronation ball will not begin to be posted until October.
- I understand that during the Miss Rodeo America Pageant, I will be helping conduct the social media coverage of the current Miss Rodeo Arkansas and the events that myself, as the Lady in Waiting, are required to participate in.
- I understand that during my reign as Miss Rodeo Arkansas, these same rules will apply to the Lady in Waiting following me.

In addition, Miss Rodeo Arkansas Scholarship Organization agrees;

- To assist Miss Rodeo Arkansas in scheduling appearances, setting travel itineraries, acquiring accommodations, and acquiring personal sponsorships. **No exceptions.**
- To assist, as needed, Miss Rodeo Arkansas in her preparation for competition in the Miss Rodeo America Pageant, including payment of entry fees and other fees in order to remain in good standing with Miss Rodeo America Inc.
