

**Miss Rodeo Arkansas Teen 2024 Performance Contract**  
(Hereinafter called “Agreement”)

This agreement is between \_\_\_\_\_, Miss Rodeo Arkansas Teen 2024, and the Miss Rodeo Arkansas Scholarship Organization.

**Miss Rodeo Arkansas Teen 2024 agrees:**

- The undersigned, having entered and participated in the 2024 Miss Rodeo Arkansas Scholarship Organization Pageant with the understanding and knowledge of the terms and conditions of this Contract and understanding that if designated “Miss Rodeo Arkansas Teen 2024,” I would be required to enter into this Contract as a condition of being so designated, I make the following statements and representations to and agreements with Miss Rodeo Arkansas Scholarship Organization.
- By signing this contract I am agreeing to abide by all rules set forth not only in this document, but also in the Organizational Rulebook, and the Perpetual Item Contract. **NO EXCEPTIONS.**
- She understands and agrees that this contract is subject to change at the discretion of the Executive Board.
  - The Miss Rodeo Arkansas Scholarship Organization has the right to alter, amend, add or remove any rule or guideline, at any time, for any reason they deem necessary to uphold the integrity of the organization.
- Miss Rodeo Arkansas Teen will not represent any brand, company or entity other than that of the Miss Rodeo Arkansas Scholarship Organization. **NO EXCEPTIONS.**
  - I have not authorized any person, business, brand, firm or corporation to use my name, photograph, voice or image nor present or future title in connection with an endorsement or advertisement of any commercial product or service: and I am not under any contract or other obligation to any person, firm or corporation with respect to my present title, and further, I have not made any commitment or have any legal obligation which would prevent my participation in any appearance as Miss Rodeo Arkansas Teen.
    - I am not under any contract that may conflict with Miss Rodeo Arkansas or its sponsors.
- I am a naturally born female citizen of the United States of America and reside in the City of \_\_\_\_\_ County of \_\_\_\_\_ State of Arkansas.
- I am a student in high school, recent high school graduate or a current college student.
- I have never been married, had a marriage annulled or have had a child. I have never been pregnant.
- I am of good moral character and have never been convicted of any crime, other than minor traffic violations.
- Miss Rodeo Arkansas Teen symbolizes the youth of Arkansas and that she is the ideal, western type American girl, and is the person who will represent professional rodeo, the equine industry and the Miss Rodeo Arkansas Scholarship Organization as she travels throughout Arkansas and surrounding states.
  - Any behavior and/or activities performed by Miss Rodeo Arkansas Teen that would contradict this ideal image may result in the termination of her reign along with the forfeiture of any and all prizes, scholarship monies and sponsorship monies, or the placement of the titleholder on travel/appearance probation.
    - This includes, but is not limited to, using illicit drugs, use of tobacco products, cursing, drinking alcohol, the commission of crimes of moral turpitude, traveling to or from any official Miss Rodeo Arkansas Teen appearance with a male companion (other than family), publicly arguing, having a poor attitude or making undue demands during any official appearance as Miss Rodeo Arkansas Teen, the placing of any inappropriate photos and/or text on the internet.
      - During the MRAT reign, MRAT may not live or stay with anyone of the opposite sex other than an immediate family member.
      - In addition, if you have a sponsored vehicle or your name and title on your personal vehicle, your non male family member shall not ride in the vehicle with you at any time.
- Miss Rodeo Arkansas Scholarship Organization may also take into consideration the actions of Miss Rodeo Arkansas Teen when she is not at official appearances.
- She agrees to utilize the social media accounts Miss Rodeo Arkansas Scholarship Organization have set up, such as, but not limited to Facebook, Instagram, Twitter, etc and will remove any photos or text she is asked to remove by Miss Rodeo

Arkansas Scholarship Organization on not only these platforms, but also her personal accounts.

- Miss Rodeo Arkansas Teen will not have a personal TikTok account.
- She agrees that as Miss Rodeo Arkansas Teen, she should create at least one post every two weeks on the social media accounts.
- To have official Miss Rodeo Arkansas Teen portraits taken by our professional photographer, Sherry Smith, in a timely manner and the board will have final approval of said portraits as well as any future photographs to be used for any publicity purposes. **NO EXCEPTIONS.**
- To secure autograph sheets to be used during her reign as Miss Rodeo Arkansas Teen. The layout of these sheets must include sponsors names and logos. **NO EXCEPTIONS.**
- As Miss Rodeo Arkansas Teen, it is important that you dress appropriately in western attire, hat, crown, banner and be perfectly groomed at all times for all public appearances. This includes hair styled neatly, nails manicured and make up on.
  - Your wardrobe must be age appropriate. No cleavage, bralessness, panty lines (dress or Wranglers) or tank tops at any event or function. Miss Rodeo Arkansas Teen is advised and expected to follow advice from the National Director on her clothing choices and styles.
  - Clean crown, banner, buckle and boots must be worn for all appearances.
    - An appearance is defined as ANY place where you might expect to meet another person interested in speaking to MRAT or looking at MRAT. This includes Miss Rodeo Arkansas Scholarship Organization meetings or events and travel to and from appearances.
  - Dark, pressed and starched blue jeans (Wranglers only) are permitted when in travel status, under chaps or where appropriate.
    - Faded blue jeans or jeans with holes are **not** permitted.
    - The titleholder will receive one warning regarding inappropriate blue jeans.
    - The second violation will result in the titleholder being required to wear only colored jeans.
- MRAT may not have any visible tattoos or facial piercings at any time during her reign.
- If any chaps are purchased through her reign, Miss Rodeo Arkansas Teen will purchase those chaps through Sara Pro - Lazy P Creations.
  - In return, you will receive an autograph bag/purse made by Sara Pro, for free, with the purchase of those chaps.
- I have achieved an advanced level of horsemanship skill.
- I have never been accused or convicted of any kind of animal abuse or neglect.
- During my term as Miss Rodeo Arkansas Teen, I will not become a contestant or participant in any other rodeo, beauty, talent or scholarship pageant or contest (with the exception of National Little Britches Association Queen or National High School Rodeo Association Queen).
- MRAT is not to attend any rodeo dances while making an appearance as Miss Rodeo Arkansas Teen.
  - In addition, MRAT should recognize that a bar, club, or tavern is not an appropriate environment for a state titleholder even if she removes her hat and crown.
- Proper phone etiquette must be used at all times! If you do not understand proper phone etiquette, call the National Director.
  - MRAT should keep the cell phone turned on silent during all appearances. At no time should MRAT answer her phone or text during an appearance. MRAT is not allowed to carry her phone where it is visible or partially visible.
- To fully communicate with the National Director concerning any and all requested appearances made of her as Miss Rodeo Arkansas Teen.
  - Any out-of-state travels must be approved by the National Director. The titleholder understands that she must be invited to attend out-of-state events by other committees.
  - **Miss Rodeo Arkansas Teen may make appearances. The only requirement is that she must notify the National Director of her travels. If you wish to attend an Arkansas PRCA Rodeo, the National Director must set those appearances up.**
- I agree to save and hold harmless the Miss Rodeo Arkansas Scholarship Organization, its Directors, Officers, sponsors, volunteers and agents for and from all liability for my actions and conduct during the term as Miss Rodeo Arkansas Teen.

- I understand that all prizes, gifts and monies may be dependent upon the sponsor to deliver them.
  - I also agree that unless illness and/or severe inclement weather should occur during my reign, that I will attend all functions and be present all days and nights during the 2025 Miss Rodeo Arkansas Scholarship Pageant.
  - I agree that my Miss Rodeo Arkansas Teen buckle, crown and banner will not be possessed by anyone but myself, worn by anyone but myself or loaned out to anyone during or after my term as Miss Rodeo Arkansas Teen without permission from the Miss Rodeo Arkansas Scholarship Organization.
  - Following appearances, Miss Rodeo Arkansas Teen **MUST** give thank you cards to each and every person on the rodeo committee, host home, and/or anyone who directly helped make your appearance be a success. **No exceptions.**
  - I agree that I will represent myself as Miss Rodeo Arkansas Teen during the year of my reign. Thereafter, I may represent myself as “Former Miss Rodeo Arkansas Teen” or “Former MRAT”.
  - I understand that funding for my role as “Miss Rodeo Arkansas Teen” is my responsibility as obtained personally or through sponsorships for fundraising events. However, I understand that the MRAR Scholarship Organization will try to assist me, in whatever ways possible, in the raising of funds as needed for my role as “Miss Rodeo Arkansas Teen”.
  - All fundraisers that may be held to benefit me during my tenure as Miss Rodeo Arkansas Teen and any donations made directly to me by an individual or an organization will be kept by Miss Rodeo Arkansas Teen.
  - I understand that at no time during my reign shall I do undue harm or unnecessarily discipline any animal within my care, mine or others’, during a rodeo or related official function.
  - At every appearance, Miss Rodeo Arkansas Teen will never be on her phone for any reason other than an immediate emergency.
  - If Miss Rodeo Arkansas Teen fails or refuses to perform the terms and conditions of the Agreement, Miss Rodeo Arkansas Scholarship Organization may in its discretion require her immediate resignation, with or without cause, and she shall immediately forfeit and return to Miss Rodeo Arkansas Scholarship Organization all awards, prizes, sponsorship monies and education funds which she received or to which she would otherwise be entitled.
    - In the event of her resignation or removal, Miss Rodeo Arkansas Scholarship Organization may select her successor who will be entitled to receive such prizes, awards and education funds as may be determined by Miss Rodeo Arkansas Scholarship Organization. If prizes are not forfeited in the event the titleholder relinquishes her title Miss Rodeo Arkansas Scholarship Organization may seek legal action against said titleholder.
      - The decision to relinquish prizes will be at the discretion of the board. Each situation is unique.
  - I understand that during the lady in waiting period, I will only refer to myself as “Miss Rodeo Arkansas Teen Lady in Waiting.”
    - During that period, I will not utilize, share or post any official headshot of myself with the Miss Rodeo Arkansas Teen crown.
      - This is included, but not limited to, social media, potential appearances, etc.
    - The National Director will be the only party scheduling appearances during the lady in waiting period and during my reign. **No exceptions.**
  - I understand that information about my coronation ball will not begin to be posted until November.
  - I understand that during my reign as Miss Rodeo Arkansas Teen, these same rules will apply to the Lady in Waiting following me.
  - **In addition, Miss Rodeo Arkansas Scholarship Organization agrees;**
    - To assist Miss Rodeo Arkansas Teen in scheduling specific appearances, ensuring her success, and acquiring personal sponsorships. **No exceptions.**

## Coronation Guidelines

### **The following is a list of guidelines to use in planning a Miss Rodeo Arkansas Teen Coronation/Fundraiser Ceremony:**

- With the help of your National Director and the Executive Board, choose a date in February for your coronation ball.
  - **Please remember the Teen coronation ball is optional.**
- Choose, with the ND and EB, a location, time, band/DJ (optional) and menu for the evening.
  - (Various civic organizations will often donate space. Contact the National Director and we will be happy to request a space.)
  - Choose an emcee; make sure to give him or her accurate information about the Miss Rodeo Arkansas Scholarship Organization and its history.
- We will work with you to find a hotel in the area that is willing to hold a block of rooms at a group rate for people that have to travel to the event.
- Create invitations to mail out to all Arkansas PRCA rodeos, Miss Rodeo Arkansas Scholarship Organization Members, sponsors, alumni, and former and potential pageant contestants.
  - You are able to invite others not included in this list.
- Invitations must be mailed 3 to 4 weeks prior to the event.
- Get all information regarding the evening to the EB President three weeks before the event including:
  - Written descriptions of all live auction items
  - Tentative list of all silent auction items
  - Number of silent auction items
- We will find an auctioneer for the live auction.
- Create a schedule for the evening of what you need help with such as: serving food, front door, silent auction- receiving money and distributing items for MRARSO and membership to sign up for.
  - We will create a signup sheet for visiting royalty at the front door.
- Create programs. (Optional)
- Have a cash box available for the door and silent auction. (You may ask the Treasurer to do this)
- Coronation ticket prices shall not be less than \$25
- Alcohol is permitted at the Teen coronation ball.

**\*\*The EB will be planning this event with you. You are not alone in this, nor are you required to plan this event on your own. We are here to help make your coronation ball a success and bring your vision to light\*\***

## **Miss Rodeo Arkansas Scholarship Organization Fundraiser Policies:**

- Each titleholder will be permitted to hold a “coronation ball/celebration” as a fundraiser.
- Miss Rodeo Arkansas Teen **IS NOT REQUIRED** to have a coronation ball.
- Titleholders are permitted to sell tickets to these events as well as hold live and silent auctions.
- Plans for this event need to be approved by the National Director and Executive Board.
- Funds generated from coronation, send-off party and money donated to the titleholder directly from their sponsor(s) will be kept by the titleholder.
